### **METHOD OF PAYMENT**

Payment for goods, professional services, and cash advancements is expected at time of arrangements and required prior to the services rendered. For your convenience, we accept cash, check, credit card (Visa, Master Card, American Express, or Discover \*Credit card transaction fees will be automatically added upon transaction by credit card processor) or an approved irrevocable insurance assignment. \*There will be a 10% fee added for Insurance Assignments

Prior to drafting any contract for goods and services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

**Basic Services of Funeral Director and Staff and Overhead ----- \$2595**

Our services include: conducting the arrangements conference; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for immediate burials, and forwarding or receiving remains.) *\*Not Included in Direct Cremation*

**Embalming ----- \$1,295**

[Except in certain special cases] Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement, such as direct cremation or immediate burial, that does not require you to pay for it.

**Other Preparation of the Body -----**

Dressing of Deceased (includes Casketing) ----- \$450

Cosmetics and Hair ----- \$250

Minimal Preparation of Deceased ----- \$600

Special care for anatomical donation and/or autopsy ----- \$450

Restoration ----- \$350/hr.

Refrigeration ----- \$1,295

If embalming is declined and the final disposition of the deceased is not completed within 24 hours of the time of death, refrigeration is required by California State regulation, Title 16 Sec. 1223(b). *Note: Our initial refrigeration fee includes 7 consecutive days. If delays are caused by your control then beginning on the 8th day, the Funeral Home will charge \$100 for each additional day of refrigeration.*

*All automotive equipment prices based on 30-mile radius, additional distance will be charged \$8.00 per mile.*

Transfer to or from airport, cemetery, outside crematory, autopsy location, return to mortuary or any other transfer of remains will be charged for the vehicle used (Hearse or service vehicle) plus \$8.00 per mile after 30 miles.

## Special Charges

<b>Forwarding of Remains to Another Funeral Home -----</b>	<b>\$3,895</b>

Our charge includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; preparation of remains [including embalming], and local transportation. Does not include additional services. Domestic flights only.

<b>Receiving Remains from Another Funeral Home -----</b>	<b>\$3,395</b>
--	----------------

Our charge includes: basic services of funeral director and staff; a proportionate share of overhead costs; care of remains; transportation of remains to funeral home and to cemetery or crematory. Does not include other services.

**Direct Cremation ----- \$995 to \$21,790**

Our charge for a direct cremation (without ceremony) includes: a proportionate share of overhead costs; transfer of remains; transportation to crematory; necessary authorizations [and cremation], Plastic Snap Lid Urn and Special Velvet Urn Bag.

*\*Loved ones over 300lbs have additional fees which are stated in GPL*

*\*Basic Service fees shall be added when coordination of services are requested by authorized person*

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a fiberboard container.

A. Direct cremation with container provided by the purchaser ----- \$995\*

B. Direct cremation with a cardboard container from our funeral home ----- \$995

C. Direct cremation with Nolan cremation container-----\$1990

D. Direct cremation with a casket purchased from the Funeral Home --- \$1,990 to \$29,790\*

*\*there is an additional cremation fee for caskets*

**Immediate Burial ----- \$2,595 to \$49,585**

Our charge for an immediate burial (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; and local transportation to cemetery. *\*In house Final View may be added at addition costs.*

A. Immediate burial with casket provided by the purchaser ----- \$2,595

B. Immediate burial with Casket purchased from us ----- \$3,590 to \$49,290

**Cremation Packages**

Our Cremation Packages includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; necessary transport for services, embalming or refrigeration (on service without visitation), transportation to crematory; necessary authorizations [and cremation]. (Does not include cost of Alternate Casket or Alternate Urn)

Package B: In House 2 hour Final View followed by Cremation ----- \$3,290\*

Package C: In House 2 hour Final View followed by Cremation w/Rental Casket ---- \$4,190\*

Package D: Cremation with ID View (30 min) ----- \$2,095\*

*\*A \$495 fee will be assessed for missed visitation time without a 4 hour notice of cancellation.*
